Finally, deregulation of the energy market can deliver real benefits for you.

Legislation has been passed that now allows your address to become part of an embedded network, which may mean cheaper electricity for you.

Embedded networks can bulk purchase electricity from a Licensed Energy Retailer, usually at significantly discounted rates.

To receive these discounts, you and your neighbours need to all agree to become part of this embedded network.

Banding together to bulk-buy your electricity

HOW DOES IT WORK?

Your current electricity bill is made up of three components that combine to create the total charge to you.

PRODUCTION COST - the cost of generating the electricity. This is approximately 48% of your bill and offers little room for discounts. Most energy retailers are unable to offer large discounts to individual customers on this part of their bill.

DELIVERY COST - the cost of delivering electricity to you. Known as the Network Tariff, this service charge is approximately 48% of your bill. It is this section of your bill where **WINenergy** can save you money. Significant savings can be made, depending on the Network Tariff that we are able to negotiate from a licensed energy retailer for you and your neighbours.

GOVERNMENT CHARGES - are approximately 4% of your bill and like most things government related, there are no discounts to be had here!

MAIN SUPPLY METER - this meter controls the electricity that enters the embedded network. It is read by the power company with whom **WINenergy** has negotiated the discounted energy rate. The bill for this amount is paid by your site management, or **WINenergy**.

YOUR INDIVIDUAL METER - this meter measures the electricity used by you within the embedded network. **WINenergy** reads this meter and bills you for the electricity you use at the discount rate. All meters are government approved and tamper-proof.

Agreement Terms and Conditions

- I/We apply for energy to be supplied to the premises by the Exempt Retailer on the terms and conditions set out below.
- I/We consent to the Exempt Retailer, or its representative, taking the necessary steps to provide energy to me/us, and to transfer my/our energy supply from my/our existing supplier (if need be). This may include arranging a final bill, changes to the metering installation and the exchange of information with energy industry participants, such as my /our energy usage and customer details.
- I/We agree to pay the Exempt Retailer, or its representative, the energy charges as set by it for the supply and usage of energy to the premises, as notified to me/us from time to time, with the initial charges being those set as per the letter of offer. The energy charges payable by me/us under this Agreement will not exceed the tariff published by a licensed electricity retailer in the Government Gazette which would apply to me/us, and the Exempt Retailer will allow any energy rebates applicable to me/us.
- I/We agree that the Exempt Retailer, or its representative, may take whatever action necessary to recover costs, if I/we fail to pay for the supply of energy to the premises. This may include the disconnection of the supply of energy.
- I/We agree that WINenergy, may give information about me/us to any credit reporting agency to obtain a consumer/commercial credit report about me/us, or to allow a credit reporting agency to create or maintain a credit information file containing information about me/us, listing defaults, and exchanging information with other credit providers under Section 18E (1) and 18K of the Privacy Act 1988.
- I/We acknowledge that I/we are responsible for payment of energy supply until such time that I/we give WINenergy at least 2 weeks notice of the date on which I/we intend to (or did), vacate the premises, and provide a forwarding address to which a final bill may be sent. If no notification has been provided to WINenergy, I/we understand that I/we will be responsible for any charges incurred under this Agreement until such time that I/we give WINenergy notice.
- I/We indemnify the Exempt Retailer, or its representative, and will keep them indemnified, and hold them harmless against any liability which arises from the supply and use of energy by me/us beyond the point of connection between the premises and the energy network, that is caused by my/our failure to comply with any obligations associated with or arising out of this Agreement.
- I/We acknowledge that if the Exempt Retailer, or its representative, has to pay a contract exit fee to terminate my/our existing energy contract, I/we will be obligated to reimburse WINenergy the amount of the contract exit fee if I/we terminate this Agreement prior to the end date of that contract.
- The terms and conditions, so far as relevant, of the Energy Retail Code and the Electricity Distribution Code as published by the Essential Services Commission apply to this Agreement, and to the extent of any inconsistency, the terms of the Codes will prevail. WINenergy can provide a copy of these Codes on request.
- WINenergy may charge me/us up to a maximum of \$1.50 per bill for account keeping services.
- I/We acknowledge that neither the Exempt Retailer, nor its representative, are responsible for any failure of supply, or for the quality, continuity or frequency of energy supply to the premises.
- Where more than one person has made this application each of them will be jointly and severally liable under this Agreement.
- I/we acknowledge having been informed in writing that I/we may have the right to elect to purchase electricity from a licensed retailer of my/our choice.
- This Agreement will become binding on me/us upon notice being given to me/us that the Exempt Retailer has accepted this application.
